

**BOARD MINUTES  
FEBRUARY 14, 2022**

The Keokuk County Board of Supervisors met in regular session, Monday, February 14, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg, Daryl Wood and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried.

8:31 a.m. - Review and approval of minutes of previous board meeting was held. Motion was made by Fred Snakenberg to approve the minutes of February 7, 2022 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

8:45 a.m. - Met with Engineer Andy McGuire regarding Keokuk County Highway Department. Andy provided quote guidelines regarding old shop building demo that includes removal, backfilling and modification of subbase. Quotes are due to the Engineer's Office on March 2, 2022 at 10:00 a.m. Environmental Edge projects asbestos removal in a week or two. Andy reminded his shared Keokuk / Mahaska Engineer position is going on 2 ½ years and updated on hiring prospects for Mahaska County.

9:10 a.m. – Setting of Public Hearing time, date & place for proposed maximum property tax levy was held. Motion was made by Deke Wood to set said public hearing for February 28, 2022 at 9:30 a.m. in the Keokuk County Boardroom as submitted. Mike Hadley seconded the motion. All ayes and motion carried. Christy Bates informed said publication will be in the February 16, 2022 News-Review.

9:15 a.m. – Various board and committee reports were held. Deke Wood attended Pathfinders, RUSS and Annual Statewide Supervisors meetings. Fred Snakenberg participated in Mental Health, Eighth Judicial District meetings and attended Annual Statewide Supervisors meeting. Mike Hadley attended the Annual Statewide Supervisors meeting in Des Moines last week.

9:20 a.m. - Discussion of old/new business and public comment was held. Chuck Kent, IT Director, entered to inform of possible jury duty this week. Deke Wood shared a conversation with Jess of Manly Construction stating he will report back with a roof and bird control proposal regarding the open-faced building used for parking at old county shop location. The proposed FY23 budget was reviewed, as well as, agenda and public hearing dates thereof.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:55 a.m.
