## KEOKUK COUNTY BOARD PROCEEDINGS JUNE 27, 2022

The Keokuk County Board of Supervisors met in regular session, Monday, June 27, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg and Christy Bates, County Auditor. Daryl Wood was absent.

Hadley moved, Snakenberg seconded to approve the agenda. All ayes and motion carried. RD Keep and Sean Strohmayer, News-Review was present.

Snakenberg moved, Hadley seconded to approve the minutes of June 20, 2022 as submitted. All ayes and motion carried.

Meeting with Engineer McGuire regarding the Keokuk County Highway Department was not held.

Hadley moved, Snakenberg seconded approval of June 27, 2022 claim listing as submitted. All ayes and motion carried.

Snakenberg moved, Hadley seconded approval of FY2022 interdepartmental appropriations resolution as submitted. All ayes and motion carried. Covers the DHS/EOC air conditioning and Courthouse HVAC upgrade expenses to date.

Hadley moved, Snakenberg seconded approval of FY2023 departmental appropriations resolution as submitted. All ayes and motion carried. These amounts were approved during the budget adoption process in March.

Snakenberg moved, Hadley seconded approval of personnel report for Jessica Buehneman, part-time Recording Clerk, Recorder's Office as submitted. All ayes and motion carried. Recorder Goldman indicated date of hire as July 5, 2022, hourly rate of pay of \$12 and scheduled 20-hour work week.

Hadley moved, Snakenberg seconded approval of personnel report regarding resignation of Todd Evans, part-time Deputy, Sheriff's Office as submitted. All ayes and motion carried.

Various Board and Committee reports was held. Snakenberg participated in an Early Childhood meeting. Hadley attended a Department Head meeting and Rural Housing Trust Fund and Area 15 financial meetings.

Discussion of old/new business and public comment was held. The Board received a letter from the Mahaska Board of Supervisors objecting to construction of a carbon dioxide pipeline proposed by the Navigator Heartland Greenway LLC in order to protect the safety and prosperity of Iowans. The fiscal year end cash count will be held on June 30<sup>th</sup>. The Courthouse will be closed on Monday, July 4<sup>th</sup>.
