

**BOARD MINUTES  
OCTOBER 31, 2022**

The Keokuk County Board of Supervisors met in regular session, Monday, October 31, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg, Daryl Wood, and Paula Rasplicka, Auditor's Designee. Christy Bates, County Auditor, presented the FY2022 budget amendment publication and voluntary Delta Vision voluntary plan options for review prior to exiting at 8:25 a.m.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Casey Jarmes, News-Review.

8:35 a.m. - Review and approval of minutes of previous board meeting was held. Motion was made by Fred Snakenberg to approve the minutes of October 24, 2022 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

8:45 a.m. - Met with Engineer Andy McGuire regarding the Keokuk County Highway as follows: received notification Keokuk County did not receive the DERA grant funding; is working to verify receipt & purchase of dump truck for Volkswagen Settlement Grant reimbursement; and met with Kyle Jacobs, Miller-Meeks staffer regarding selected V5G project.

9:00 a.m.-Public hearing regarding possible vacation of a portion of road right of way on 180<sup>th</sup> Street located in Section 18, Township 76N, Range 11W and possible decision thereof was held with Engineer McGuire. No oral or written comments were received. Deke Wood moved, Fred Snakenberg second to close the public hearing at 9:05 a.m. All ayes and motion carried. Motion was made by Fred Snakenberg to approve the road right of way vacation on 180<sup>th</sup> Street as submitted. Deke Wood seconded the motion. All ayes and motion carried.

9:15 a.m. – Setting of time, date and place for proposed FY2023 Keokuk County budget amendment public hearing was held. Motion was made by Fred Snakenberg to set the public hearing as 9:30 a.m. on November 14, 2022 in the Boardroom of the Keokuk County Courthouse. Deke Wood seconded the motion. All ayes and motion carried.

9:20 a.m. – Various Board and Committee reports was held. Deke Wood attended 1015 Transit and Regional Planning Agency meetings. Mike Hadley attended Area 15, Board of Health and Rural Housing Trust Fund meetings. Fred Snakenberg had no meetings last week.

9:30 a.m.- Discussion of old/new business and public comment was not held due to no additional topics to review.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:35 a.m.
