

**BOARD MINUTES
NOVEMBER 21, 2022**

The Keokuk County Board of Supervisors met in regular session, Monday, November 21, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg, Daryl Wood and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Dan House and Casey Jarmes, News-Review.

Board consensus directed Bates to contact a rock hauler and also check into bird repellent spikes.

9:25 a.m. – Keokuk County Board of Supervisors approval of Auditor of State recount order by authorizing Keokuk County Auditor and Commissioner of Elections to conduct said recount if proper request is filed with the Keokuk County Auditor is not necessary since Todd Halbur, Republican candidate, conceded said race to Rob Sand, incumbent.

9:30 a.m. – Meeting with Keokuk County Librarians was held with Toni Greiner, Keota Librarian; Cindy McCan, Richland Librarian and Amanda Kelly, Sigourney Librarian, with each giving an update and annual review of their specific library.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:55 a.m.
