

**BOARD MINUTES  
DECEMBER 12, 2022**

The Keokuk County Board of Supervisors met in regular session, Monday, December 12, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Daryl Wood and Christy Bates, County Auditor. Fred Snakenberg was absent.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Mike Hadley seconded the motion. All ayes and motion carried. Also present was Casey Jarmes, News-Review.

8:35 a.m. - Review and approval of minutes of previous board meeting was held. Motion was made by Mike Hadley to approve the minutes of December 5, 2022 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

8:45 a.m. - Met with Engineer Andy McGuire regarding the Keokuk County Highway Department as follows: received road complaints due to the overcast and drizzle noting is the worst weather for gravel roads, especially if recently bladed; an email was received notifying that Keokuk County was selected as one of ten or twelve counties as a IJA infrastructure grant recipient for the bridge north of Richland and just north of the railroad tracks; Andy reached out to Pathfinders regarding possible projects. Bridge updates: Hwy 78 bridge – the deck is poured and they are working on approaches; Hwy 92 bridge – work is yet to be completed on the approaches and guardrails. Jim Reynolds was present to share concerns regarding speed and parking on V45/Keswick road. Andy recalled researching this matter previously, discussed city and county jurisdiction and will look for the file and report thereafter.

9:25 a.m. – Possible approval of Caryl Cavner to Keokuk County Conservation Board was held with Curtis “Pie” Reighard, Director. Pie informed Caryl agreed to fill Greg Dyers’ upcoming vacancy on said Board and feels he will be a progressive member. Motion was made by Deke Wood to approve Caryl Cavner as a Keokuk County Conservation Board member as submitted. Mike Hadley seconded the motion. All ayes and motion carried. The five-year term becomes effective on January 1, 2023.

9:30 a.m. – Various Board and Committee reports was held. Deke Wood attended the Delta Vision meetings. Mike Hadley had no scheduled meetings last week.

9:40 a.m.- Discussion of old/new business and public comment was held. Drew Sanders, Assessor/GIS was present to discuss scheduling a date for the Conference Board meeting. Consensus was to set the date as January 19, 2023 at 7:00 p.m. in the Courtroom of the Keokuk County Courthouse.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:55 a.m.
