

**KEOKUK COUNTY BOARD PROCEEDINGS  
DECEMBER 27, 2022**

The Keokuk County Board of Supervisors met in regular session, Tuesday, December 27, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg, Daryl Wood and Christy Bates, County Auditor.

Wood moved, Snakenberg seconded to approve the amended agenda to include the addition of the Sheriff's Deputy Resolution update. All ayes and motion carried.

Snakenberg moved, Wood seconded to approve the minutes of December 19, 2022 as submitted. All ayes and motion carried.

Wood moved, Snakenberg seconded approval of County Sheriff's Deputy resolution appointment update to include Jacob Butler and David A. Heady and removal of Todd Evans as submitted. All ayes and motion carried.

Snakenberg moved, Wood seconded approval regarding designation of Sigourney News-Review as the official newspaper for Keokuk County for calendar year 2023 as submitted. All ayes and motion carried.

Hadley moved, Snakenberg seconded approval of Heather Wilson, Deputy Recorder's four-year appointment as submitted. All ayes and motion carried.

Snakenberg moved, Wood seconded approval of Cathy Clawson and Tammy Klett, Deputy Treasurer's four-year appointments as submitted. All ayes and motion carried.

Wood moved, Snakenberg seconded approval of quarterly interfund operating transfer from Rural Services Fund (\$430,000) and LOST Fund (\$80,750) to Secondary Roads Fund totaling \$511,250 as submitted. All ayes and motion carried.

Various Board and Committee reports was held. Snakenberg attended Early Childhood and SADC meetings. Hadley attended 911; Area 15 and Semco meetings. Wood had no meetings to attend last week.

Discussion of old/new business and public comment was held. KONE elevator passenger safety modules were discussed.

Hadley moved to approve a 9% wage increase for elected officials based on the cost of living allowance and to include Secondary Roads in said increase, exceeding the 3% union contract increase for FY24. Motion died for lack of a second. Snakenberg moved, Hadley seconded to approve an 8½ % wage increase across the board for elected officials for FY24, to include the Secondary Roads department as stated in prior motion. A roll call vote was held: Snakenberg – aye; Wood – nay; Hadley – aye. Also present were: Assessor/GIS Sanders; Conservation Director Reighard; Treasurer Edmundson Long, and Recorder Goldman.

On vote and motion Hadley adjourned the meeting at 9:35 a.m.
