8:30 a.m.- Meeting was called to order. Motion was made by <u>Deke Wood</u> to approve the agenda. <u>Fred Snakenberg</u> seconded the motion. All ayes and motion carried. Also present was RD Keep, News Review.

8:31 a.m. - Review and approval of minutes of previous board meeting was held. Motion was made by <u>Fred Snakenberg</u> to approve the minutes of February 22, 2022 as submitted. <u>Deke Wood</u> seconded the motion. All ayes and motion carried.

Motion was made by <u>Fred Snakenberg</u> to set the FY23 Keokuk County budget public hearing for March 14, 2022 at 9:30 a.m. in the Keokuk County Courthouse Boardroom 1st floor. <u>Deke Wood</u> seconded the motion. All ayes and motion carried.
