

**KEOKUK COUNTY BOARD PROCEEDINGS**  
**AUGUST 29, 2022**

The Keokuk County Board of Supervisors met in regular session, Monday, August 29, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg, Daryl Wood and Christy Bates, County Auditor.

Wood moved, Snakenberg seconded to approve the agenda. All ayes and motion carried. Also present was Casey Jarnes, News-Review.

Snakenberg moved, Wood seconded to approve the minutes of August 22, 2022 as submitted. All ayes and motion carried.

Wood moved, Snakenberg seconded approval of 28D Agreement between Mahaska County Board of Health and Keokuk County Board of Health as submitted. All ayes and motion carried. Eric Dursky is employed to perform sanitarian duties involving septic systems and wells for the Keokuk County Board of Health. This is a continuance of the existing 28D for the next two years.

Snakenberg moved, Wood seconded approval of personnel report for hire of Paula Rasplicka, Auditor's Payroll Designee as submitted upon passage of the upcoming pre-employment physical. All ayes and motion carried.

Wood moved, Snakenberg seconded approval of personnel report for hire of Robyn Miover, Auditor's Real Estate Designee as submitted. All ayes and motion carried. Passage of the pre-employment physical was received.

Snakenberg moved, Wood seconded approval of personnel report for hire of Devan S. Fraise, Sheriff's Office, part-time jailer/dispatcher as submitted. All ayes and motion carried.

Various board and committee reports was held. Wood attended a 1015 Transit meeting. Hadley attended Board of Health, Area 15, Iowa State Association of Counties (ISAC) and Department of Transportation Service Agency Board meetings. Snakenberg had no scheduled meetings last week.

Discussion of old/new business and public comment was held. Berg entered to discuss continued service on the English River Watershed Board. Board consensus was to confirm by official action following receipt of paperwork from Jody Bailey, ERW Project Coordinator. Custodian Kiebel was present to discuss receipt of water conditioner bids that will be placed on next week's agenda for formal action and reminded the light bar still needs to be installed on the JD Gator to help with upcoming snow removal. Treasurer Edmundson Long provided replacement claim and Local Option Sales Tax (LOST) estimated payments for FY2023.

On vote and motion Hadley adjourned the meeting at 9:20 a.m.
