

**BOARD MINUTES  
NOVEMBER 14, 2022**

The Keokuk County Board of Supervisors met in regular session, Monday, November 14, 2022 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg, Daryl Wood and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Casey Jarnes, News-Review.

8:35 a.m. - Review and approval of minutes of previous board meeting was held. Motion was made by Fred Snakenberg to approve the minutes of November 7, 2022 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

8:45 a.m. - Met with Engineer Andy McGuire regarding the Keokuk County Highway Department. Last week the following was held: motor grader training and operation, flagger training, quarry and mining safety and chainsaw operation and maintenance, as well as the annual safety meeting last Thursday; and continue to work on preparation for snow removal. Discussion arose regarding current contact with Don Burdock regarding extension of a field entrance. Board consensus was no recollection of said claim or agreement thereof.

9:00 a.m.- Meeting with Michelle Herman, Veterans Affairs/General Assistance Coordinator, regarding the General Assistance budget was held. Michelle informed she is requesting a funding increase to the rent, utilities and funeral line items that equates to \$14,000 due to the number of current requests for assistance. Board consensus was to allow said request, although bump the amount up to \$20,000 due to anticipated requests for assistance instead.

9:25 a.m.- Various board and committee reports was held. Deke Wood attended Pathfinders and RUSS meetings. Fred Snakenberg participated in Mental Health and SEIL meetings. Mike Hadley had no scheduled meetings to attend last week.

9:30 a.m.- Public hearing regarding proposed Fiscal Year 2022 Keokuk County Budget amendment and possible approval of budget appropriations resolution thereof was held. The Conservation amendment is a pass-through Fish Habitat grant for \$220,000 and the Elections amendment is carrying forward unused FY22 HAVA Cybersecurity grant expenditure of \$10,000 into the FY23 budget. No oral or written comments were received. Motion was made by Deke Wood, seconded by Fred Snakenberg, to close the public hearing at 9:32 a.m. All ayes and motion carried. Motion was made by Fred Snakenberg to approve the FY2022 amendment and appropriations resolution as submitted. Deke Wood seconded the motion. All ayes and motion carried.

9:40 a.m.- Discussion of old/new business and public comment was held. The Kiwanis provided a pavilion progress update for review. An ISG county inspection update was provided for review as well.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:45 a.m.

The Keokuk County Board of Supervisors adjourned to meet November 15, 2022.
